NHS South West London Integrated Care Board (SWL ICB) is seeking to appoint a provider for the provision of a high quality, safe, Community Vasectomy Service comprising of pre-operative counselling, procedure, and post vasectomy testing. The service will provide safe non-scalpel technique vasectomy under local anaesthetic (LA) in primary care settings for all residents living in the boroughs of Croydon, Kingston, Merton, Richmond, Sutton and Wandsworth.

The contract to be awarded is for an initial duration of 3 years, which is intended to run from 1 October 2025 until 30 September 2028 with a two-year contract extension up to 30 September 2030. The estimated total annual contract value is £228,529

and total contract value over the full term is £1,142,645.

The Services to which this Procurement relates to fall within the scope of Schedule 1 of the Health Care Services (Provider Selection Regime) Regulations 2023. As such, the procurement of the service is being run as a bespoke single stage application process akin to the Open Procedure.
