Foreign, Commonwealth and Development Office (FCDO) is looking for a supplier of services to deliver Wajibika Programme in Tanzania (Wajibika).

Wajibika is led by the FCDO and co-designed/funded by the Swiss Development Corporation (SDC).

The anticipated Financial Limit for the Contract until 31 March 2030 is up to £24,125,000. This value is made up of £13,500,000 representing the UK funding for the programme, and of approximately £10,625,000 (CHF 11,700,000) representing the Swiss Embassy contribution. The Contract value is inclusive of all applicable taxes but exclusive of UK

VAT.

The Wajibika Programme is made up of three Components:

- Component 1 - Inclusive and Effective Civic Space;
- Component 2 - Media Freedom Workstream; and
- Component 3 - The Governance Innovation Fund.

The Financial Limit of the Contract, irrespective of value, will be allocated to the three components in the following proportions: Component 1 - 60%, Component 2 – 20% and Component 3 – 20%.
