This approach focuses on a collective approach among partners to support communities to maintain a healthy weight long term, as part of a county-wide approach. The 10 Pillars are summarised below. The first six pillars will contribute to preventing people from becoming overweight and obese, the seventh pillar will offer support to people who are already overweight, and the final three pillars are approaches/principles that will help us to effectively achieve and measure the first seven pillars.
