- Upright or inverted microscopes using laser technology such as Confocal, Spinning Disc, TIRF and Multi-photon including associated imaging equipment such as slide scanners.
- Deterministic super resolution and stochastic super resolution microscopy equipment such as simulated emission depletion (STED), ground state depletion (GSD), SPDMphymod.
- Specialist camera components for image acquisition in relation to life science applications and materials research.
- Modular digital imaging and microscope software for image acquisition, processing and analysis.
- Light Sources and associated equipment, including but not limited to: Incandescent Lamps, Halogen Bulbs, Arc Lamps, LED Light Sources.
- General Accessories and Consumables, including but not limited to: Objectives, Filter Sets, Stands, Eyepieces, Adapters.
- Comprehensive or preventative maintenance and repairs of standard "off-the-shelf" equipment beyond its initial envisaged life cycle term.
