- All suppliers should respond to the request within the time scales required. Failure to do so, will mean the Supplier will not be considered for that request.
- All requests received within the timescales will be evaluated and an order will be placed with the supplier offering the lowest price, so long as they can deliver by the delivery date specified. If the delivery date cannot be met, then we reserve the right to place an order with the next lowest supplier and so on.
- An Order Form will be sent to the supplier confirming the details of the request and the supplier shall sign and return the Order Form, which will be confirmation that the supplier will deliver the requirement.
