The United Kingdom Ministry of Defence (the "Authority") intends to place a new design and build contract with Devonport Royal Dockyard Limited (the "Company") to support the 10 Dock and 5 basin berth construction at Devonport Royal Dockyard specifically for a O2 workshop. This contract is a call off from the current Integrated Partner Framework, NEC 4 which was signed between the Authority and the Company in December 2020 for both the assessment and construction phases of the works at Plymouth Naval Base to facilitate berthing and docking for deep maintenance period of Astute Class submarines. The value is estimated at £3.7 million and the expected duration is 24 months.
