The purpose of the Prior Information Notice (PIN) is for early engagement with the market prior to undertaking a formal tender process. We will be seeking input from the supply market to inform our requirements, to help formulate our specification for the services and help identify routes to market. There is the possibility this waste stream will be included as an additional Lot under the Avon & Somerset Waste Management Services tender.
