ii) Delivering a quality-led and young person-centred service with suitably trained and consistent staff that enables young people to feel safe and protected from harm and progress towards achieving positive outcomes.

iii) Providing long-term support planning and proactive assistance with young UASC's transition into independence.

iv) Assessing needs and enhancing the self-support skills of UASC's, enabling them to live independently once they have received their Right to Remain with the UK.

ii) Providing supported accommodation for up to two young people, alongside one emergency placement, within a single 24hr staffed property for 24hrs a day, 7 days a week, 365 days a year.

iii) Delivering a quality led, person-centred service that is flexible and sensitive to each individual young person's support needs.

iv) Supporting young care leavers to develop the skills needed to live independently, enabling them to make informed decision-making and achieve positive outcomes.
