The V60's underlying proprietary electronics, software stack, and control system for complex actuated systems are the only suitable platform available to the market that will effectively support stable and assured weaponisation. Edgar Brothers have a unique position with Ghost Robotics Corporation as their exclusive reseller to the UK market, and as such they have been chosen as the Supplier for this contract.
