The overall objective of this work is to require a supplier to deliver and build on the action plan created by Fresh Thoughts which aims to improve water stewardship and management through collective action work in previously identified priority locations in Southern Spain, specifically, the main fruit and vegetable production areas in the regions of Andalusia, Murcia and Valencia.
