Graveney School: A mixed secondary schools with circa 2,200 pupils aged 11-18. The school has approximately 15% of pupils eligible for free school meals.

Tooting Primary School: A mixed primary school with circa 400 pupils aged 4-11.

Franciscan Primary School: A mixed primary school with circa 300 pupils aged 2-11. The school has nursery classes

Basis of Contract

The Trust wishes to appoint a single supplier to deliver full catering services to all schools. The contract will commence from 1st August 2024 and will be for an initial period of 3 years plus an option to extend for a further period of 1 plus 1 years.

The total turnover estimated for all schools is circa £2.8 million (over 3 years).

- Sufficient local resources to ensure the required level of service is constantly maintained.
- Familiarity with successfully managing high volume commercial budgets in secondary schools

- A compelling attitude towards making the lunchtime service appealing, healthy and educational for children.
