The anticipated contract value is £80,000 - £100,000 over the initial contract period. The estimated annual contract value is £20,000-£25,000.

Adult survey results are currently published twice a year and children and young people survey results annually. The accurate and timely production of results requires considerable quality assurance in advance of the publication of the survey results.
