VII.2) Information about modifications

VII.2.1) Description of the modifications

Nature and extent of the modifications (with indication of possible earlier changes to the contract):

To modify the end date of this contract to 31st March 2027, enabling the Council to take advantage of beneficial future fixed rates presented for the next two years through the agreement. This in turn would provide a level of stability and continuity of provision.

The previous modification varied the end date by one year to 31st March 2025.

VII.2.2) Reasons for modification

Need for additional works, services or supplies by the original contractor/concessionaire.

Description of the economic or technical reasons and the inconvenience or duplication of cost preventing a change of contractor:

In reliance on Regulation 72(1)(e) of the Public Contracts Regulations 2015 to vary the contracts for Casualty, Property, Motor Fleet, Engineering Inspection to modify the end dates by two years to 31st March 2027.
