### **Framework operation description**

Rochdale Council uses a basket of goods approach to evaluate supplier pricing. Each

supplier submits unit prices for a predefined set of items, and the total basket cost is calculated to compare bids consistently.

Suppliers can apply for specific lots within the framework agreement. Bids are scored based on price and quality criteria, and the top three highest-scoring suppliers per lot are awarded a place on the framework.

Either with or without competition
