This contract encompasses a wide range of brickwork-related tasks, including repairs to residential properties, estates, communal areas, and facilities. Specific duties involve rebuilding boundary and party walls, tank housings, and performing localised repointing. Additionally, the scope extends to ground works, paving, blockworks, and elevated structures such as chimney stacks and parapet walls.
