Providing good quality design and better integration into adjacent areas there is potential for Queens Gardens to create a magnificent public space and an improved area to host major events.

Within the scheme, the Authority has included sustainable tree management proposals and opportunities to improve biodiversity. Significant amounts of new tree planting is included within the scheme, 13 of which are in a heavily constrained city centre public realm location.
