In-centre Haemodialysis is provided across five sites; Salford, Wigan, Bolton, Oldham and Rochdale. Plans are underway to replace the Rochdale site with a new site in Heywood by the end of 2022. This may or may not form part of the scope.

The current service manages the West Sector of Greater Manchester, which has a population of around 1.5 million, with approximately 450 dialysis patients between the units, and approximately 50 patients dialysing at home. The Trust has identified a strategic opportunity to improve the regional service, standardise procedures and working practices throughout the landscape, improving and providing patient care closer to home.

The submission of an expression of interest is not a pre-requisite to any subsequent procurement application; however the response to this market engagement advert will help to inform the procurement approach, including whether or not a competitive process will be appropriate, i.e. a lack of expressions of interest may be used to evidence the appropriateness to award a contract direct without a competition.
