Research has shown that the pandemic has had an impact on the ability of EY settings to identify and support children with SEND. It has also had an impact on family and home environments, which as well as affecting children already in early years care, has affected children who will enter early years provision during the Covid-19 pandemic recovery period i.e. between now and August 2024.

The Department for Education intends to increase specialist expertise in SEND by increasing the number of Level 3 qualified SENCOs in group based settings and childminder settings, at a critical time for early years children, and in particular at a time when the Covid-19 pandemic has significantly reduced opportunities to identify and address SEND amongst children not yet of compulsory school age.
