1-That activities will be co-produced and co-delivered with young people. The provider will also be required to support the implementation of the #YES (Youth Engagement Strategy) by working with young people on seeking their ideas, views and aspirations on long term plans for youth provision in the City of Wolverhampton;

2-Experience of providing universal detached provision.

3-Can engage more and different young people, including vulnerable young people who may be on the cusp of involvement in ASB or other low-level crime or who may be fearful of accessing youth provision in the area or who have been a victim of crime;

4-Contribute consistently to young people's development; socially and emotionally;

5-Be able to draw in additional resources that can strengthen any future offer for example, trips, activities, equipment, resources, etc..
