- Increased resilience to reduce the risk of care breakdown and inappropriate hospital admission.

Desired outcomes for the person with Dementia

- Care needs continue to be met whilst their carer has a break.
- Increased access to social stimulation and local outings.

Outcome 4 - The workforce is resilient and supported through the provision of supervision and continued professional development.

Outcome 5 - The Service is flexible and responsive, adapting to the individual needs of the person in terms of their circumstances i.e. strengths, level of risk, culture, ethnicity, language, age and disability.
