The Service supports a range of Individuals with varying levels of needs across a range of

care cohorts including, but not limited to older people, people with mental health needs including dementia, those with a physical disability or sensory impairment, learning disabilities, autism, neurodivergences, care leavers, people recovering from addictions and people fleeing domestic violence.

1. The Council is conducting the procurement under Section 7 Regulations 74-76 Social and other Specific Services under the Public Contracts Regulations 2015 (PCR 2015). An open procedure is being used.

2. There is an option to extend the contract for a period of 24 months after the initial 5 year term.

3. The estimated value in II.2.6 is for the 7 year period i.e. initial term of 5 years and 2 year extension option.
