It is anticipated that the Framework Agreement will be established for a term of 4 years and will allow the Council to award work, depending on the circumstances, by way of direct award and through reopening of competition amongst providers which are party to the Framework Agreement (i.e. by way of a mini-competition). The Council does not currently anticipate that there will be a limit to the number of providers who can be appointed to the Framework Agreement.

A Tenderers' Information Event ("the Event") will take place ahead of the Tender opportunity being published. This will be held in-person on Council premises in Committee Room B of the Town Hall in Halifax on 24/03/23 from 10:00 - 12:00 (providers will also be able to attend virtually via MS Teams).
