- The supplier must be able to meet the specific requirements of the call-off (e.g., technical capability, geographic coverage, relevant specialism).
- If more than one supplier is suitable, the Authority will proceed to the next criterion.

2. Availability

- Among suitable suppliers, the Authority will identify which supplier(s) can deliver the requirement within the required timeframe.
- If more than one supplier is available, the Authority will proceed to the next criterion.

3. Cost

- Where multiple suppliers remain suitable and available, the supplier offering the lowest total cost (in line with Framework pricing schedules) will be awarded the call-off.
