The weighting was determined by the procurement panel to give appropriate relative importance to the questions asked and ensure that providers could evidence and assure the Commissioner through the Most Suitable Provider Process of their skills, knowledge and experience in delivering primary medical services and to provide robust patient involvement through the process.
