The flooring needs to meet safety specifications, be hard wearing and offer a 20 life.

The flooring work must be completed during the Summer Holidays 2021.

The school area is approx 2500m<sup>2</sup> and has a ground floor and first floor, the stairs are also included. Communal areas included are the dining hall, all corridors and stairs but excluding changing rooms and bathrooms.

The school has 2 buildings and would like a quote to be split (in case the work cannot be completed in one session over the summer) The intend to have all the work done but need to be realistic with the timeframe and have requested the buildings are split so two quotes are provided if the work were to take longer than expected.
