tariff is comparable to, or cheaper than, a bus fare;

The Council wants to procure up to two dockless cycle hire operators who are capable of deploying a total of 2,500 dockless e-bikes in the borough-wide network of designated cycle

hire bays, for a contract duration of 5 years under a concessions contract (3+1+1 years).

Potential operators should be members of an appropriate industry body and be able to manage a contract with a turnover of up to £34 million per annum.
