Adhering to the principles of UK.gov's Should Cost Model, which aims to achieve competitive market pricing whilst avoiding a 'race to the bottom', B2G will then recalculate and reissue pricing data, for reference on projects registered in the new term,

The shortened term will enable all parties to better withstand market and supply chain volatility, with pricing remaining current, competitive, durable and viable. The automatic renewal will ensure optimum efficiency.

To ensure the framework remains open, fair and competitive at all times, at each renewal date additional suppliers may also be appointed, subject to submitting a bid and being evaluated and awarded by B2G in accordance with the same criteria and terms.
