Justification:

The Tender is being conducted under the Accelerated Procedure which means that it is a single stage process. MDC has determined that a state of urgency exists that renders impracticable the time limit laid down in the PCR. The rationale for this is that MDC have previously advertised within OJEU the tender for the Supply, Delivery, Installation, Maintenance and Support of an Electronic Laboratory Notebook, however unfortunately a technical error resulted in clarifications not being publicly available. Due to this MDC have cancelled the previous tender and reissued the tender with the full set of clarifications. The contract for this is required to start by Monday, 2nd August 2021 considering time for evaluation and implementation of the system MDC do not have the time to undertake a full open procedure tendering exercise.
