These Contracting Bodies will be responsible for ordering of, and payment for, their own services through this agreement.

The key outcome of this tender is to ensure a co-ordinated, effective response to COVID-19.

High quality training to address the now universal requirement for basic digital skills, in virtually all roles. Such training could be offered to quite large cohorts and include collaborations with corporates to ensure maximum impact.

Package to include training for those with no, some and developing digital skills.

Given evidence shows access likely to be lower in deprived areas, ensure districts with lower skills rates / higher unemployment are targeted as well as BAME groups and individuals with disabilities.
