At least one front loading washer and dryer per launderette must be installed at low level to be accessible by students with disabilities. To refurbish the respective launderette (and other area disturbed by installation) following installation of new machines to also include making good where necessary, to include redecoration and flooring. The University will supply gas, electricity, water and drainage at the Laundrettes where possible. All existing provision in relation to the current service will be removed, including pressurised tanks and will need to be assessed by the tenderer, to establish needs for their proposed service provision.
