Tewkesbury Borough Council is a rural district authority located in the northern part of Gloucestershire and is responsible for the management and maintenance of two public Cemeteries:

- Bishops Cleeve Cemetery, Kayte Lane, Bishops Cleeve
- Tewkesbury Cemetery, Gloucester Road, Tewkesbury

These Cemeteries are always open to the public and serve a wide and diverse community both locally and from further afield.

This service is typically arranged through funeral directors and includes:

- Mechanical and manual excavation of graves

- Interment of ashes
- Preparation of the graveside
- Backfilling after burial or interment

This procurement seeks a reliable and professional Contractor to deliver grave digging services in accordance with the Employer's standards and sensitivity to the nature of the work.
