The Trust also recognises the importance of having the MIS as the 'Single Version of the Truth' in respect of pupil and staff records as the source of all identities across all systems within the Trust which, in conjunction with an automatic identity management tool should ensure seamless, automatic update processes wherever possible. In this way, as far as is practicable, the Trust wishes to avoid:

- Duplication of the effort currently involved in replicating key data fields across a variety of applications;
- Manual data transfer processes which require human intervention;
- Data transfers which involve scheduled 'batch' processes as these lead to latency in updates;
