The service provides specialist diabetes care for patients aged 19 years and over for patients with Type 1 and Type 2 Diabetes, but will work with the Paediatric Diabetes service to ensure appropriate and safe transition for all patients moving away from the paediatric service into the Integrated Diabetes Service. The treatment will be over varying lengths of time, according to the clinical needs of the person with diabetes.

In ordinary circumstances, this support will be available on an intermittent basis only as the prevailing ethos should be to provide competent self-care and independence with support from primary and community based care.

The new proposed contract will be for a period of 12 months with the option to extend for a further 12 months. The new contract will start on 1st April 2023 and will end on 31st March 2024 with the option to extend from 1st April 2024 to 31st March 2025.

The Hertfordshire and West Essex Integrated Care Board (HWE ICB) became a legal entity on 1st July 2022, replacing the previous Hertfordshire and West Essex Clinical Commissioning Groups.
