MCFT intends to contract with Barnardo's, Leeds Support Office, Rockford House, Low Lane, Horsforth, Leeds, LS18 5QW. This service works closely with St Helens CYPMHS to provide a range of evidence based therapeutic and preventative services to children

and young people. The contract value is approximately £864,607.

MCFT is currently in contract with Barnardo's and has been for a number of years. For the new contract MCFT intends to contract for the service for a period of a further 12 months from 01 April 2024. It is intended to award the contract in accordance with the Provider Selection Regime Regulations under Direct Award Process C where there is an existing provider for the services and that existing provider is satisfying the original contract and will likely satisfy the proposed new contract, and where additionally the services are not changing considerably.

The Senior Leadership Team of Community Care Division have made the decision for the award of this contract. No conflicts of interest have been identified and this has been recorded in line with Trust policy.
