This service is seen as an essential element for overall site security and protection. This will include the monitoring of both intruder and fire alarms. The ARC will be required to notify to 1st point of contact (agreed by the Council) and the emergency services when the alarm is triggered. The types of sites include corporate buildings, schools and any other customers of Coventry

City Council. The new ARC will be required to work with the existing ARC (where applicable) to transfer all existing alarms. This excludes installation.
