MCFT intends to contract with Think Therapy, Oaktree House, 52 Briarfield Avenue, Widnes, WA8 8JZ. This service works closely with mid-Mersey CYPMHS teams to provide CBT and Counselling services to children and young people. The contract value is approximately £180,000.

MCFT is currently in contract with Think Therapy. For the new contract MCFT intends to contract for the service for a period of a further 12 months from 01 April 2024. It is intended to award the contract in accordance with the Provider Selection Regime Regulations under Direct Award Process C where there is an existing provider for the services and that existing provider is satisfying the original contract and will likely satisfy the proposed new contract, and where additionally the services are not changing considerably.

The Senior Leadership Team of Community Care Division have made the decision for the award of this contract. No conflicts of interest have been identified and this has been recorded in line with Trust policy.
