The service aims to assist Service Users in their recovery by involving them in all aspects of their care and treatment in a format that they can understand and to return them to the community as quickly as possible. The service will also:

- Provide specialist assessment and /or treatment which is planned and reviewed with the service user, their family, and carers to assist with their recovery.
- Develop comprehensive individual health assessment with the service user, involving carers and involved health professionals.
- Promote person centred and recovery focused care and treatment plans based on individual needs and provide services which are flexible and responsive to gender, ethnicity, cultural, religious, physical, and sensory needs.
- Provide advice and recommendations to the community teams, carers, other agencies regarding transfer of care needs including section 117 aftercare where appropriate.
- Provide a joined-up service, working together with the community teams, sharing information with others as and when appropriate, and in line with Trust Policies and relevant inter-agency policies.
