The framework agreement was extended to 30th January 2021 to allow SUPC to conclude the tender process for the SLRA.

The modification does not alter the overall nature of the contract, the overall nature of the contract is unaltered, lots, economic operators and subject matter of the contracts.

During the retendering process of the SLRA, a bidder to the tender sought further information and clarification to the tender process. The decision was made to stop the standstill period, reissue award notification documentation and restart the standstill period. The framework was extended to allow SUPC sufficient time to conclude the tender process.
