To embed online safety education and digital resilience across schools and community settings • Deliver online safety programmes in schools. • Provide professional training for staff and safeguarding leads. • Offer interactive workshops for pupils and SEND learners. • Distribute resources and guidance to schools and families. This would need to include a response to key areas of concern in keeping young people safe online. • Whole school approach (students, teachers, parents, wider community - police and other professionals) • Consistent approach to online safety training and the provision of relevant key messages • Young people led - gives them a voice • Knowledge and

consideration of the Online Safety Act. Impact on online safety awareness Metrics to include: • Number of schools engaged • Number of pupils trained • Feedback from staff and pupils Reporting: Termly updates to PCC and partners. If the business case is approved, a compliant procurement route will be taken at the point of purchase.
