The Place, Connectivity and Infrastructure Professional Services Collaborative Framework 2022 - 2026 (PCI) is designed to provide Hampshire County Council with multi-disciplinary and specialist professional services in the fields of transportation, civil engineering, infrastructure and economic growth.

Although Hampshire County Council are the Client and the PCI will be managed by Hampshire County Council, other Authorities can call off services from this Framework via Hampshire County Council on a Participating Authority agreement basis.

This Framework shall operate for 4 years from 1 March 2022 to 28 February 2026 and will be for the provision of multi-disciplinary and specialist professional services in Hampshire and other geographical areas within England. Whilst the upper estimated threshold for the contract is £100,000,000 over the 4-year life of the Framework, across both Lot A and B Lots B1-B10, there is no guarantee of any services being awarded. It is however envisaged that the annual throughput could be in the region of £11,000,000 per annum. The throughput will depend on variables such as available funding and use of the Framework by other Authorities.
