The service should be holistic in its provision and work to improve the person's psychological well-being, social functioning and participation in everyday activities and to reduce the likelihood of negative outcomes associated with pain and impaired function arising, such as depression, social isolation and loss of employment.

- Provision of and training in the use of appropriate equipment for people.
- Advice, information, education and training for other healthcare staff including GPs and other professionals and organisations to improve knowledge and ability to support people with their planned MSK and physiotherapy techniques and programmes in order to improve people's functioning and management of their musculoskeletal condition.
- Advice, information, education, training and support for people and their family/carers/friends on understanding and managing their own condition and how to improve their functioning. This will include provision of treatment and self-management plans and written and web based information.

This interim contract is for 12 months with a value of circa £1m dependent on patient activity. Rights are reserved to extend this contract by up to a further 12 months, with a potential overall value of £2m (24 months)

Explanation:

Taking account of the unprecedented impact of Covid-19, the normal commissioning process has been disrupted and it is no longer possible, both in terms of timescales and in terms of service continuity risk, to conduct a competitive procurement for these services ahead of a new contract start date on 1st April 2021.

Observing its obligations under the NHS (Procurement Patient Choice and Competition)(No.2) Regulations 2013, NHS SWL CCG has assessed the appropriateness to award an interim contract directly through a non-competitive process to the incumbent provider(s), recognising an immediate need to ensure continuity of essential patient services whilst a full review takes place to agree the future provision of these services.
