There would be no continuity between programme work streams if a new supplier was awarded the pre-mobilisation workstream alone. The time required for a new supplier to upskill to deliver pre-mobilisation would exceed the length of pre-mobilisation itself, therefore to ensure continuity and avoidance of duplicate costs this modification has been made. A change in supplier would cause significant inconvenience, delay and duplication of costs for the department.
