The service will include:

Postoperative Cataract Follow ups

- A post-operative assessment following cataract surgery to be performed by optometrists in optical practices for those people who have uncomplicated surgery and no significant comorbidities specifically requiring a hospital post-operative assessment (i.e. most patients).
- The outcome and dataset required to complete the NOD cataract audit is reported to the surgical provider, as recommended by NICE NG77 and GIRFT.
- Patients with low-risk post-operative issues to be managed by their optometrist

Hydroxychloroquine Screening

- Annual screening of all Northamptonshire patients prescribed Hydroxychloroquine or Chloroquine and at risk of retinopathy.
- Where appropriate, onward referral to HES including all diagnostic findings.

Stable Glaucoma Monitoring

- Annual monitoring of a fixed cohort of patients diagnosed by the HES as low risk of contracting Glaucoma.
- Where appropriate, onward referral to HES including all diagnostic findings.

The contract will be for a period of 3 years with the option to extend for up to a further 2 years, commencing 1st August 2026.
