A Prior Information Notice (PIN) was published via Public Contracts Scotland (PCS) on 17 October 2021, with a request for interested parties to register their interest no later than 12 noon on 17 November 2021. 6 companies noted an interest by this specified closing date, and as part of market engagement for this opportunity, a questionnaire was issued to those same suppliers. The University has found that based on all questionnaire responses received, only 1 company (Enwa Water Technology UK (UKBR006388)) can fulfill the requirements set out under the Prior Information Notice (PIN).
