Nature and extent of the modifications (with indication of possible earlier changes to the contract):

NHS Norfolk has received funding from NHS England to support the implementation of

opt out HIV Virus ("HIV") testing at the Norfolk & Norwich University Hospitals NHS Foundation Trust Emergency Department. This funding comprises a fixed element of £10,000 for education and resources, as well as a variable element of £7.50 per HIV test undertaken, up to a maximum of £147,771.

The effective date of this modification is 14/07/2025 and the value is £155,771.00.
