Healthy Pregnancy Service: Stop Smoking Enhancement to support improvements to the delivery of the Healthy Pregnancy Service through increased reach to expectant and new families and ongoing support to those families and enable the provision of Nicotine Replacement Trust (NRT) at the earliest opportunity.
