PFT is seeking to appoint a multi-disciplinary design team to deliver RIBA Stages 1-7 on the key redevelopment works identified as “Phase 2” in the PFT masterplanning exercise undertaken in late 2021.

The master plan is split into four phases:-

Phase 1 – Studio and Foyer Extension (works currently on site and due for completion in Spring 2022)

Phase 2 – Main Building refurbishment, rehearsal room relocation and workshop and office upgrades

Phase 3 – Garden and Landscape

Phase 4 – Redevelopment of Port Na Craig facilities and site

The contract is anticipated to commence in September 2022 at RIBA Stage 1 and last for a period of approximately 25 months.
