This is classed as regulated work under the Protection of Vulnerable Groups (Scotland) Act 2007, therefore any person undertaking regulated work must be a member of the PVG scheme for the type of work being undertaken prior to any contracts being awarded.

Suppliers must have the relevant licence(s) or permits at the award stage i.e Private Hire, Taxi Operator etc as well as appropriate insurances.

The minimum selection criteria for appointment to the DPS is successful completion of SPD(s) including PVG.

The award criteria may be more precisely formulated at tender stage (mini-competitions). This may involve changes to the current 90/10 weightings and there may be further quality criteria added.

Operators who do not submit their applications by Friday 26th April at 4.00 pm may therefore join too late to be able to tender for business from the start of the 2024/25 school term.
