### **VII.2.2) Reasons for modification**

Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

The re-procurement exercise for this framework is underway, with the Contract Notice due to be published imminently. Further time than originally anticipated is required to complete the procurement strategy, therefore procurement timelines have been extended. Full
