In addition, Xoserve has IT systems which will allow some verification activities against claims made to BEIS the online portal to BEIS.

Xoserve provides the industry standard database for UK gas connections, allowing the most up to date look at active and capped gas connections, and includes the information on properties that are not connected to the gas grid. Their database is updated regularly and used extensively by the private sector, including for both household consumption, and the delivery of gas into the UK's system from abroad.
